- If Public Health Wales or substantially all of its assets are transferred to a third party organisation, in which case personal data held by it about its customers will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use [Please see our Terms and Conditions page] and other agreements; or to protect the rights, property, or safety of Public Health Wales, our customers, or others.
